Details of the workshop feedback and action taken report:

Workshop evaluation of speakers, considering quality and effectiveness of presentations, interaction with the participants, time management and appropriate use of learning aids were at a mean average of 4 in a Richter scale of 1-5. Evaluation of participants were a mean average of 4/5 Richter scale on the basis of punctuality. On the basis of interactions in sessions, participation in group tasks and enthusiasm were 5/5. The workshop's program schedule and organisation were evaluated to be as per the standard format of MCI.

Comments: The participants appreciated the contents, delivery of presentations, the activities given and the quality of teaching aids, the arrangements in general and the food. Mean score on the retro per- workshop was an average 1.8/5 and they post- workshop score was an average 4.2/5.

Actions taken: The sessions which scored relatively lesser were improved in the subsequent workshops. The overall concept, the content and delivery of the presentations were intensely scrutinised and improved with several rehearsals before each workshop. Regarding the punctuality of the participants, it was decided to set stricter rules before workshops itself. It was also proposed to use a QR code embedded in the identity cards issued, which was scanned on entry. Implementing this in the subsequent workshops was found to improve the punctuality of the participants.
